Consultation Report: Double yellow lines at junction of Samuels Close and West Street

September 2023

1. Background

- 1.1 During the consultation for double yellow lines for Dolben Avenue and Mansfield Street a request was received to consider double yellow lines on the junction of Samuels Close and West Street.
- 1.2 "It's a real run-the-gauntlett (sic) along Spencer Parade at the best of times, and it's often impossible to see out from the top of Samuels Close, with parked cars right up to the corner on both sides. Yesterday morning saw a new level of stupidity when someone pulled up on Spencer Parade opposite the top of Samuels Close too!"
- "...further to the consultation regarding double yellow lines on Dolben Avenue, please can I raise the prospect of applying them close to the junction of Samuels Close and Spencer Parade? Cars park along Spencer Parade right up to the junction, making it very difficult to see out. It often results in cars driving past the parked cars at some speed, then ducking into the apron of Samuels Close in order to let oncoming vehicles through. This has resulted in some very close calls. There are also many incidences of road rage on that stretch of Spencer Parade, which is very narrow and endures high traffic volumes, all exacerbated by the number of cars parked along its length."

2. Timeline

17th August 2023: Parish Council agrees to undertake consultation exercise (Minute ref 23.82)

22nd August 2023: Notice of consultation exercise posted on Facebook (see Appendix A), the notice board and the Parish Council website inviting comment from the wider area.

22nd August 2023: consultation letters hand delivered to properties of Samuels Close and 6 properties on West Street and 1 on Green Lane. (See Appendix B)

8th September 2023: Consultation closed

21st September 2023: Discussed at Council

Appendix C

Anonymised Comment on Samuels Close/West Street double yellow line consultation

Comment for

F1 Our only concern is that the vehicles that currently park in the proposed yellow line area will be forced to park further up Spencer Parade which could then further limit the pull in spaces needed at busy times for traffic to get through.

F2 Very good idea. But not gone further enough. Spencer Parade is now being used as a short cut to the A45 since the new estates have built in Raunds. Vehiceles (sic) are speeding through the village and not giving way to other traffic. Eventually this will end resulting in a serious accident as vechicles (sic) are even mounting the pavements with no regard for pedestrians.

F3 About time. Can it be introduced that all vehicles do not park on the pavements. This encourages the mad drivers to go even faster through the road especially the cars parked up on the mainly left hand side out of the village via West St.

F4 and I am responding to the request about the introduction of double yellow lines at the entrance to the close and West Street.

F5 It is extremely dangerous trying to exit Samuels Close due to parked cars – it is like joining a busy road with a blind fold on. Several of the cars are from residents of Samuels Close too! There is going to be an accident.

F6 I am fully supportive of this introduction of double yellow lines. I have previously involved in a car accident trying to get out of Samuels Close due to the poor visibility (along with a speeding other driver!).

F7 Exiting from Samuels Close has become a major problem. Because of inappropriate and illegal parking. We have had several near-misses. We hope that double yellow lines might make for greater road safety.

F8 Parking by the entrance to Samuels Close has been a significant danger since I first moved in (approx. 17 years).

Parked vehicles obscure the view of passing traffic causing extreme caution to be taken.

Even with caution, I have encountered several near misses.

I am aware that it is constantly the same vehicles parked to one side of the entrance. One of which is a large truck. This is particularly awkward to negotiate when turning out.

I would also add that delivery vans often ignore the yellow lines further down West Street which further compounds the problem.

A blanket double yellow line would also discourage this flaunting of the road markings.

Thank you for considering this action. You have my full support.

A1 We are not in support of the yellow lines at the junction Samuels Close / West St.

If the lines go ahead it will cause problems for us residents in Green Lane. The lane isn't very wide and as there are a number of elderly residents living here so we regularly get ambulances visit. There have been problems in the past where the residents of West St have parked in Green Lane obstructing access and the footway.

Green Lane is an unadopted road and unless a solution can be found to stop the cars that regularly park on Spencer Parade parking here too then we are very much against it.

A2 I have been informed of the proposal to request that double yellow lines at the junction of Samuels Close and West Street and

I would like to add the following comments:

- * There currently is not enough parking to have this taken away
- * The road would be made more hazardous as it would be easier for drivers to speed
- * The Terrace Houses 1 5 (behind the black railings) would have nowhere for their visitors to park or if they are a multiple car family. We do own Green Lane (council only acquired right of Way for Green Lane residents and left ownership with our 5 Terrace Houses) and could use this but are currently in a dispute with the Lady just moved into the bungalow on the corner of Green Lane/Samuels Close as she believes she owns the road. Albeit it is on our house deeds, I feel that if we start parking on the lane more, I'd need to most days, disputes will worsen.
- * If the wall that was recently re-pointed could be dug out and moved back for parking then it would be a solution, but it would not stop speeding traffic. Cars already think this is a short cut through to Raunds, it would make it easier for vehicles to move through the village and I feel would up the volume of already busy traffic as it would take away an obstacle.

Not sure why this has been brought up now as has never been an issue before.

A3 We do not support the introduction of yellow lines as shown on the letter because it will cut down parking by at least 5 places which in turn will cut down the parking in Villa Lane because the people who use the parking in Spencer Parade will probably have to use Villa Lane!
