Stanwick Allotments and Community Garden Risk Assessment

Location

North side of Raunds Road at Parish Fields

Description

The 2 acre site is situated on Parish Fields. It is fully enclosed by stock fencing, with a pedestrian gate and a vehicle access gate. The gates are secured by a combination padlock.

The site is divided into 29 allotments and a community garden.

Water is provided by stand pipes.

The site is accessed from Raunds Road via a purpose built road access and a pedestrian gate. These conform to highway standards.

The Council has arranged for boulders to be placed on the adjoining verge to ensure cars are not parked on the verge which may obstruct the sight lines of drivers exiting the allotment access.

Each allotment holder has a tenancy agreement with the Parish Council. Allotment holders are required to observe the Allotment Rules that are designed to ensure the safe operation of the site.

Facilities

None within the allotments site.

Allotment holders may apply to erect a shed or poly-tunnel on their plot for which they are responsible for.

The Council does not provide any tools to allotment holders.

The Community Garden has a poly-tunnel and 6 raised beds.

Users

Allotment holders must be over the age of 18 years.

Where Stanwick School, Pre-school Play Group and Acorn Nursery use the site, they will be responsible for undertaking their own risk assessments and for the safety and security of the children in their care. They will be responsible for ensuring the correct adult to child ratio and child protection.
