Welcome to my latest Update.

The coronation of His Majesty The King and Her Majesty The Queen Consort will take place at Westminster Abbey in two weeks' time. If you haven't made any plans yet to celebrate this historic occasion locally, the official **Coronation** website is a great source of information. You can type in your town or your postcode to find out about events that are happening in the local area. If you are organising an event in your area, it is not too late to add it to the map!

I also wanted to highlight that **The Big Help Out** is starting on Monday 8 May. It would be really interesting to find out more about what is taking place in the local community on this – and the wider coronation plans. Yesterday the Executive met in the Council Chamber at the Corby Cube. The Executive considered a number of reports on a range of areas including the provision of funding to two local schools to help improve their facilities; Traffic Enforcement at George Street in Corby, and a proposal on the A43 Northampton to Kettering Improvements Phase 3. All of these were approved, and I have provided more details on these items below. If you missed the live streaming, you can watch the recording on our **YouTube** channel. The **agenda** and **papers** are on our website.

It was announced this week that a total of 3,793 reception places and 981 junior school (Year 3) places have been allocated to pupils across North Northamptonshire. 98.6% of reception places and 100% of junior school places were allocated to preferred schools.

If you're planning to celebrate life events, such as marriage or civil partnership, you will love our new **Weddings and Ceremonies** web pages. The new section has recently gone live. It is now quite dynamic with a vibrant identity, it's also user-friendly and easy to navigate.

The council has several current open consultations. These are wide-ranging in their subject matter: a proposal for an energy park near Burton Latimer, a local cycling, walking and infrastructure plan for Kettering, a survey on the health and wellbeing services which support children and young people and their families, and a plan to address the accommodation needs of gypsies and travellers. Please feel free to fill in the online questionnaires which are available on our **Consultation and Engagement Hub**.

You can also have your say on the future shape of services providing 'short-breaks' for children with disabilities in Northamptonshire. The Northamptonshire Integrated Care Board and Northamptonshire Children's Trust have developed a potential new model for the services and are looking for feedback via an online **questionnaire** before going any further.

The first of two rounds of funding for local community projects – the **Augean revenue and small grants fund** – is open for applications for another three weeks. The funding supports revenue projects up to £10,000 and capital projects of up to £5,000. If your project or organisation is situated within a 10-mile radius of Augean's landfill sites, you have until Friday 12 May 2023 to apply online.

Not-for-profit organisations based in Corby can apply for funding opportunities for nature projects in the area. The Discover Northamptonshire Team is working with the National Lottery Heritage Fund to promote the £3,000 to £10,000 grants and has organised two free sessions next week so organisations can find out more and apply.

Our workers have been out clearing up litter again in the North Northamptonshire area. This time it was from a one mile stretch of the A6003, which links Kettering and Corby, over three days last week, with four people collecting 172 bags of rubbish.

The dates of next month's Armed Forces Community Hub sessions have been confirmed. All members of the Armed Forces community are welcome to attend to gain advice and support, or just pop by for a chat. The May sessions will take place in Northampton, Daventry, Kettering and Brackley.

Traffic safety measures

The improvement of safety measures for pedestrians along George Street in Corby was discussed at yesterday's Executive meeting.

Following a previous phase which looked at the safety of pedestrians across a section of George Street and saw the upgrade of an existing zebra crossing and the introduction of a tiger crossing, alongside other changes, a second phase is proposed to introduce enforcement cameras along a small section of George Street.

The proposed works will improve the accessibility, mobility and safety for pedestrians and cyclists.

Executive approved a report that recommended the replacement of the existing Traffic Regulation Order governing the main crossing in George Street to operate Monday to Saturday between 8am to 6pm restricting access to buses, taxis and cyclists only.

They also approved the introduction of enforcement with the use of Automatic Number Plate Recognition to seek to improve the safety for pedestrians.

The project will be funded through the Accelerated Fund, which is part of the Town Fund.

We are aware there are other areas of North Northamptonshire which are suffering from similar issues, which is why the report also proposes that £25,000 is utilised to undertake investigation, traffic studies and feasibility works for further schemes across the local area.



North Northamptonshire Council set to pledge joint working on A43 major road scheme

Building a dual carriageway the length of the A43 between Kettering and Northampton is set to move a step closer – helping to relieve congestion and improve journey times.

So far, the stretch of the A43 between the Round Spinnery roundabout and the newly built Overstone Grange roundabout has been dualled, with work taking place in three phases between 2015 and 2020.

The proposal presented to Executive yesterday outlined how the next phase – known as Phase three – would see the dual carriageway continue from Overstone Grange to the Holcot/Sywell roundabout.

While the first phases are in the West Northamptonshire Council area, this next stage crosses over the border into North Northamptonshire.

Because the scheme crosses the boundary, it will be jointly developed by the two councils and, as the majority of the scheme lies within West Northamptonshire, West Northamptonshire Council will be the lead authority, with appropriate involvement and funding from North Northamptonshire Council.

As such, the report before North Northamptonshire Council's Executive yesterday proposed that the council signs a Memorandum of Understanding with neighbouring West Northamptonshire Council to develop this next phase. This was approved.

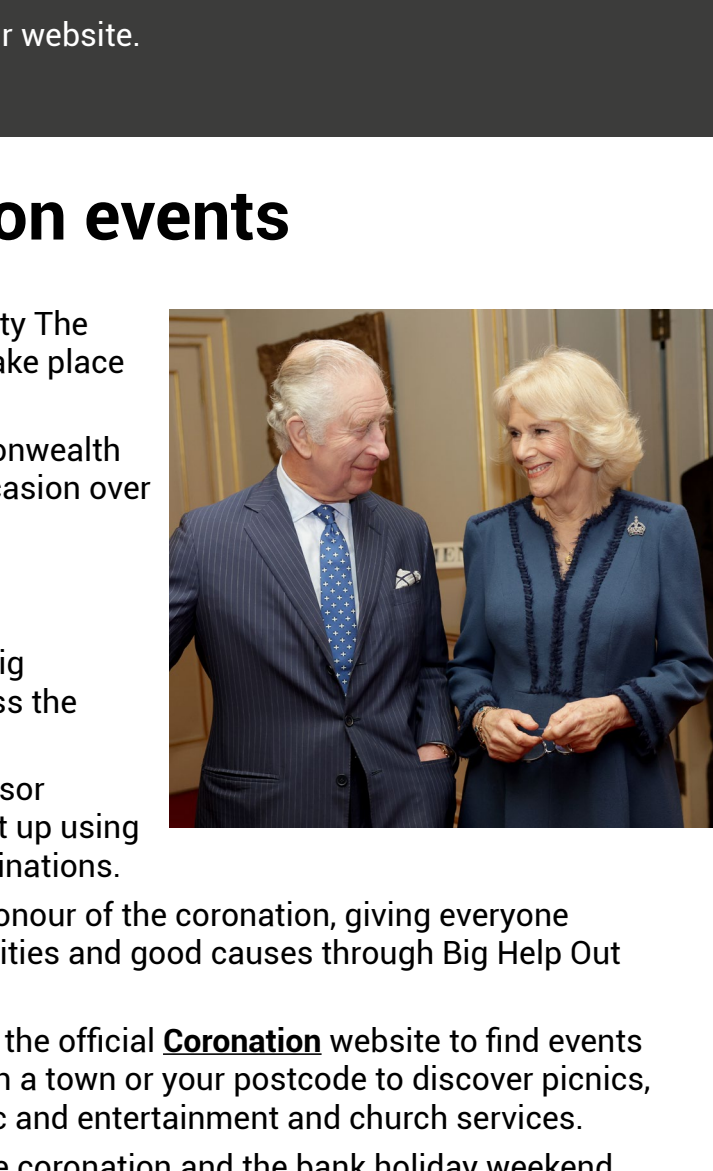
A similar proposal went before **West Northamptonshire Council's Cabinet** on Tuesday 11 April.

Subject to the signing of the Memorandum of Understanding, work will then progress to prepare the outline business case.

Subject to gaining the necessary approvals and funding, it is anticipated that construction could begin in early 2026, with completion in Spring 2027.

I welcome these next steps in a vital infrastructure project for the area and look forward to seeing this work begin.

A better-connected North Northamptonshire is so important for everyone and this scheme is heading in the right direction.



Places allocated for primary-aged pupils in North Northamptonshire

It was announced this week that a total of 3,793 reception places have been allocated to pupils across North Northamptonshire.

Allocations to reception

- One of their preferred schools: 98.6%.
- First preference: 93.2%.
- Second preference: 4.3%.
- Third preference: 1.1%.

More people than ever before (99%) made their applications online.

Families who applied for their primary school place online and within the deadline can **check their offer** online.

A total of 981 junior school (Year 3) places have also been allocated to pupils across North Northamptonshire.

Allocations to junior schools

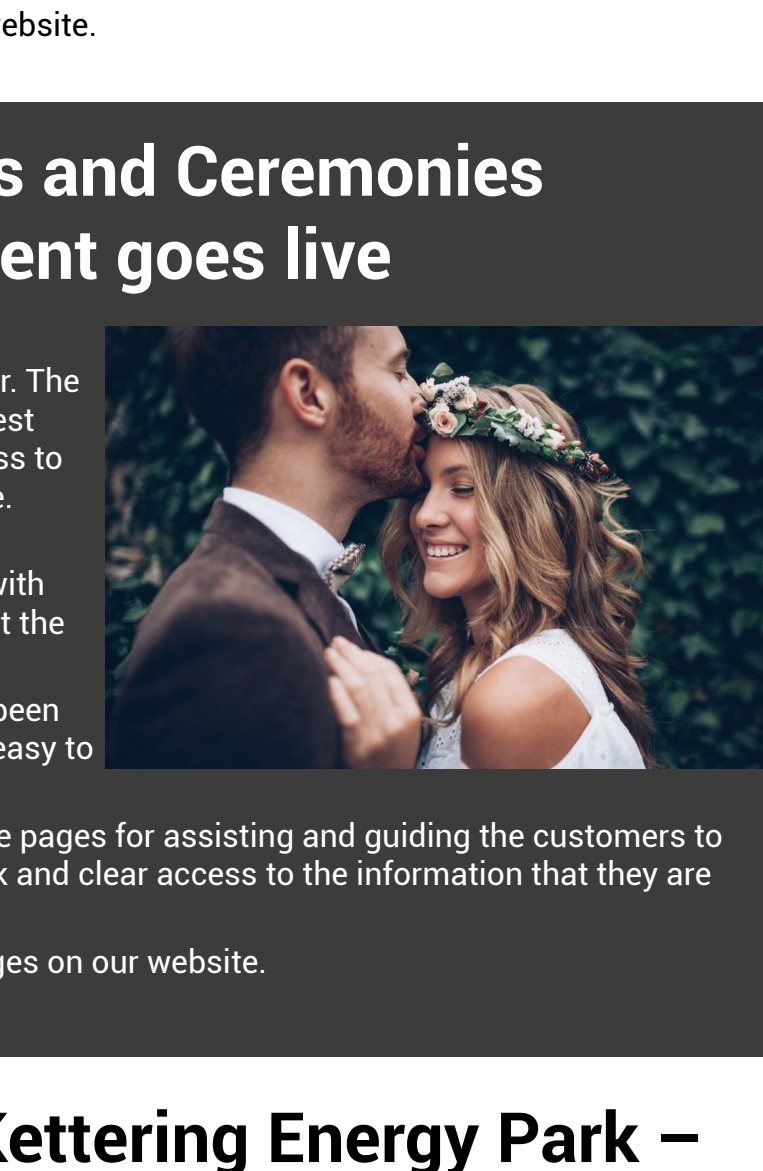
- One of their preferred schools: 100%.
- First preference: 99.9%.

Any parent has the right to appeal (through the independent appeals process) against refusal of a place at any school for which they have applied.

The next round of primary school place allocations (for late applicants) will take place in May.

Communities across the nation and the Commonwealth will come together to celebrate this historic occasion over a weekend of special events:

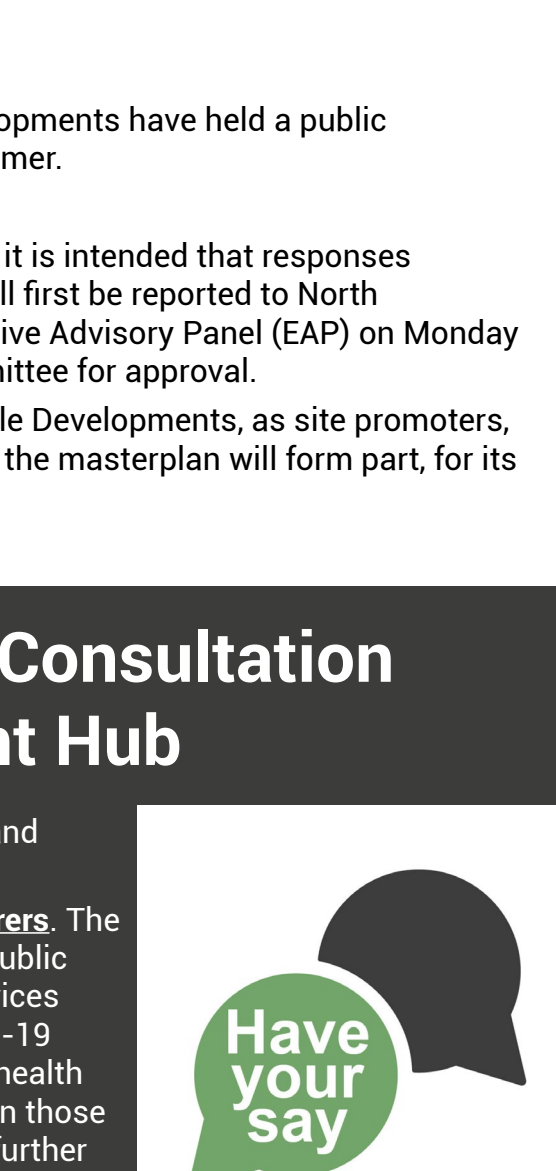
- **Saturday 6 May** - Coronation Ceremony at Westminster Abbey, London.

New Weddings and Ceremonies web content goes live

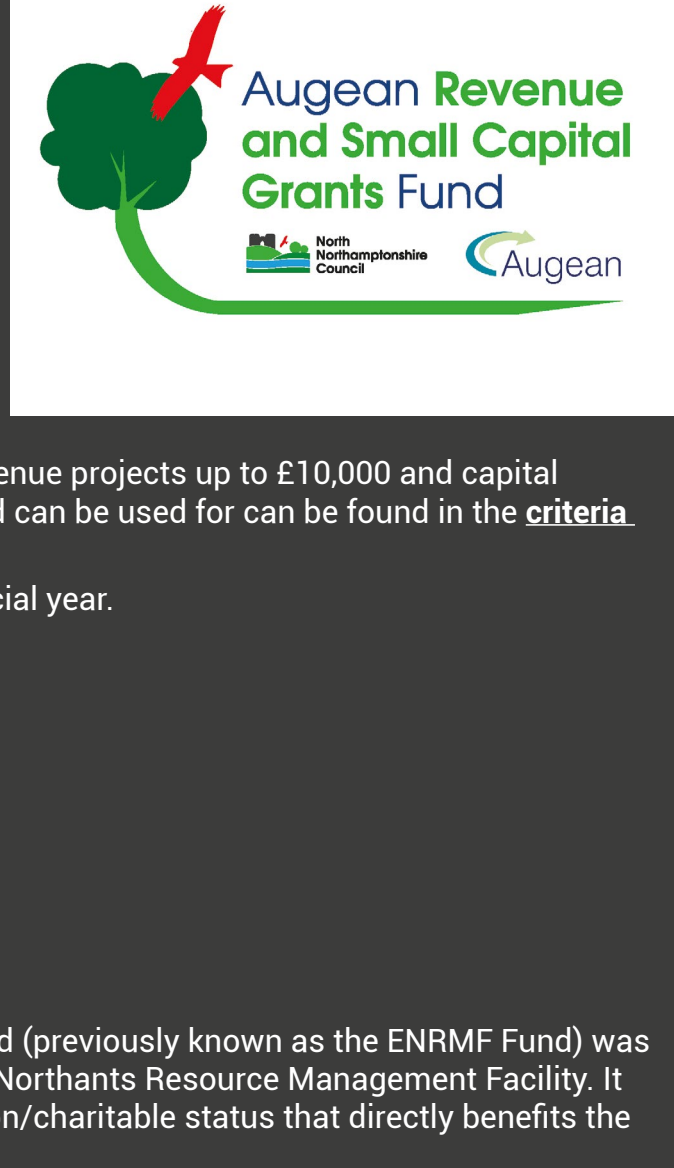

Have your say on Kettering Energy Park – Draft masterplan document

Residents are being asked to have their say on proposals for an energy park to the east of Burton Latimer.

First Renewable Developments have prepared a draft masterplan for Kettering Energy Park which outlines a vision for the site at Burton Wold and how it could be developed.

The masterplan will guide proposals and applications related to renewable energy, including how new employment opportunities could be brought forward.

The proposal fits with the Joint Core Strategy (or Local Plan) for North Northamptonshire, which identifies land at Burton Wold as the main area of local opportunity for an 'energy park'.

Public consultation

The masterplan is currently subject to a seven-week public consultation which runs up until Monday 22 May.

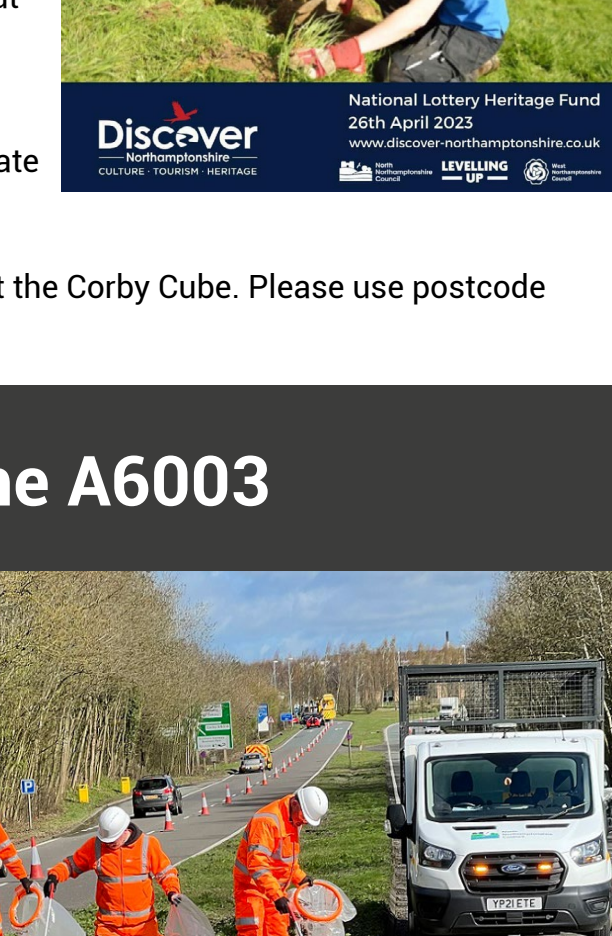
Engagement event

Next steps

Following the seven-week consultation on the masterplan, it is intended that responses received, plus any changes proposed to the document, shall first be reported to North Northamptonshire Council's Planning Communities Executive Advisory Panel (EAP) on Monday 12 June 2023 and then forwarded to the appropriate committee for approval.

Following this process, it is understood that First Renewable Developments, as site promoters, shall submit planning applications to the Council, of which the masterplan will form part, for its consideration.



Open activities on the Consultation and Engagement Hub

- **0-19s CYP Health Needs Assessment – Parents and Carers.** The North Northamptonshire and West Northamptonshire Public Health Team is assessing the health and wellbeing services which support Children and Young People (CYP) aged 0-19 and their families, to gain understanding of the current health and wellbeing needs, demands and any improvements in those services across Northamptonshire. There are also two further surveys being shared with School Staff and Stakeholders/Providers to gather feedback from all interested parties. Closes 28 April 2023.

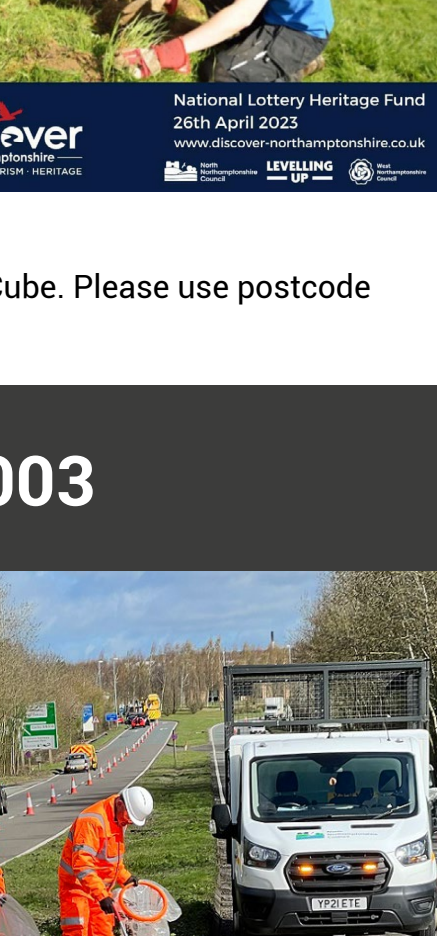
- **Kettering Local Cycling, Walking and Infrastructure Plan.** Following earlier consultations with local residents and stakeholders North Northamptonshire Council (NNC) has drafted a Local Cycling and Walking Infrastructure Plan (LCWIP) for Kettering, in collaboration with WSP and Brightwayz, Closes 19 May 2023. This is the first of our LCWIPs. We will also be producing such plans for Corby, Wellingborough and Rushden/Higham Ferrers.

- **Gypsy and Traveller Local Plan – Scope and Options.** We are consulting on the plan to address the accommodation needs of Gypsies and Travellers. The Scope and Options consultation invites views on what should be included in the plan. Closes on 31 May 2023.

Improving services for children with disabilities

Message from Northamptonshire Integrated Care Board and Northamptonshire Children's Trust.

Residents are being invited to have their say on the future shape of services providing 'short-breaks' for children with disabilities in Northamptonshire.

Short breaks are breaks for children and young people with disabilities which give them rich opportunities while also allowing their carers to have a break from caring to carry out other vital activities they may not otherwise be able to do.

Currently Northamptonshire Children's Trust and the NHS Northamptonshire Integrated Care Board fund a range of different services from a number of different organisations to provide these breaks ranging from residential and non-residential breaks, personal care and support, holiday clubs, sensory

impaired services and sleep support.

Having worked with parents and practitioners the organisations have developed a potential new model for the services and are looking for feedback on this before going any further.

The new proposed model would bring all current short break services into one offer, led by one organisation – as opposed to the current situation where services are provided across a range of different organisations. The aim is to ensure these services are better joined up to meet the needs of families.

Augean revenue and small grants fund

The application process for the Augean revenue and small grants fund is open until Friday 12 May 2023.

Augean plc manages landfill sites in King's Cliffe and Rothwell. As part of this, some of their revenue (Section 106 monies) is given back to fund local community projects.

The council administers the scheme to fund projects within a 10-mile radius of Augean's landfill sites. Before applying, projects and organisations should **check online** that they are situated within the radius.

Total funding changes every year and supports revenue projects up to £10,000 and capital projects of up to £5,000. Examples of what the fund can be used for can be found in the **criteria and guidelines**.

There are two funding rounds in the 2023/24 financial year.

Round 1

- Open: 1 April 2023
- Deadline: 12 May 2023.
- Outcome: Mid-June 2023

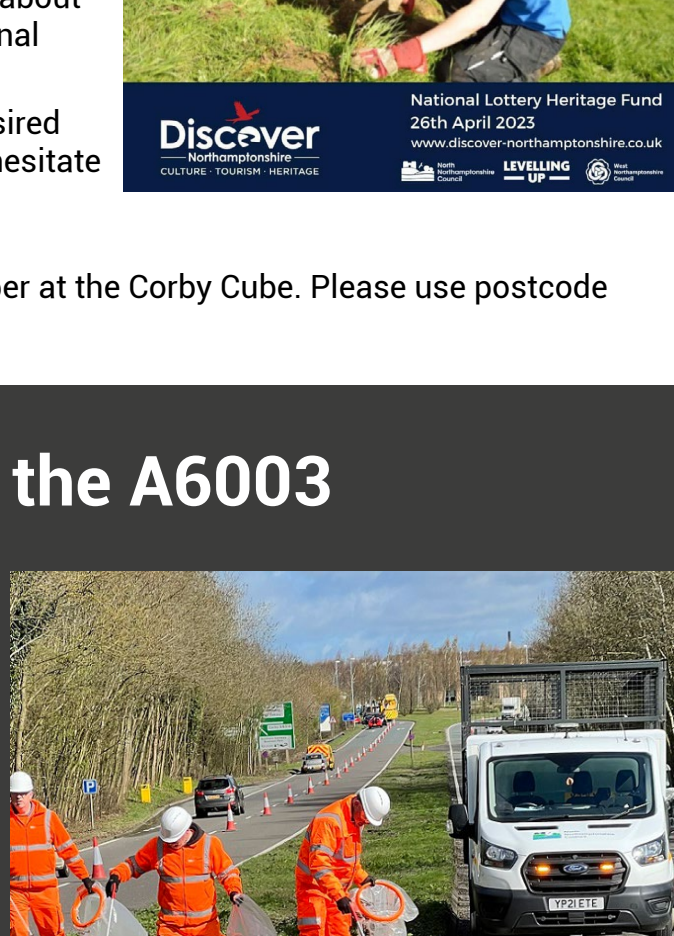
Round 2

- Open: 2 October 2023
- Deadline: 10 November 2023
- Outcome: Mid-December 2023

The Augean Revenue and Small Capital Grants Fund (previously known as the ENRMF Fund) was set up as part of the planning consent for the East Northants Resource Management Facility. It aims to support any organisation with a constitution/charitable status that directly benefits the community within a 10-mile radius of the sites.

Litter pick on the A6003

Our workers have been out clearing up litter again in the North Northamptonshire area. This time it was from a one mile stretch of the A6003, which links Kettering and Corby, over three days last week, with four people collecting 172 bags of rubbish.

Litter-picking is a simple action that anyone can do to make an immediate and visible difference to their area – a Keep Britain Tidy survey showed 85% of those who took part in last year's Great British Spring Clean reported that taking part made them feel more pride in their local area. And 74% said it improved their mood too!

Emergency Alerts service

On Sunday 23 April 2023 at 3pm, there will be a national test of the UK Emergency Alerts service.

The UK government's new system will enable people to be contacted via their mobile phone when lives are in danger. It will be used to warn you in the event of emergencies, such as severe flooding.

Emergency Alerts are sent to all compatible mobile phones within an area of risk. They don't track your location, need your phone number or collect personal data. Only the government and the emergency services will be able to send them. If you don't have a mobile phone, you'll still be kept informed through other channels.

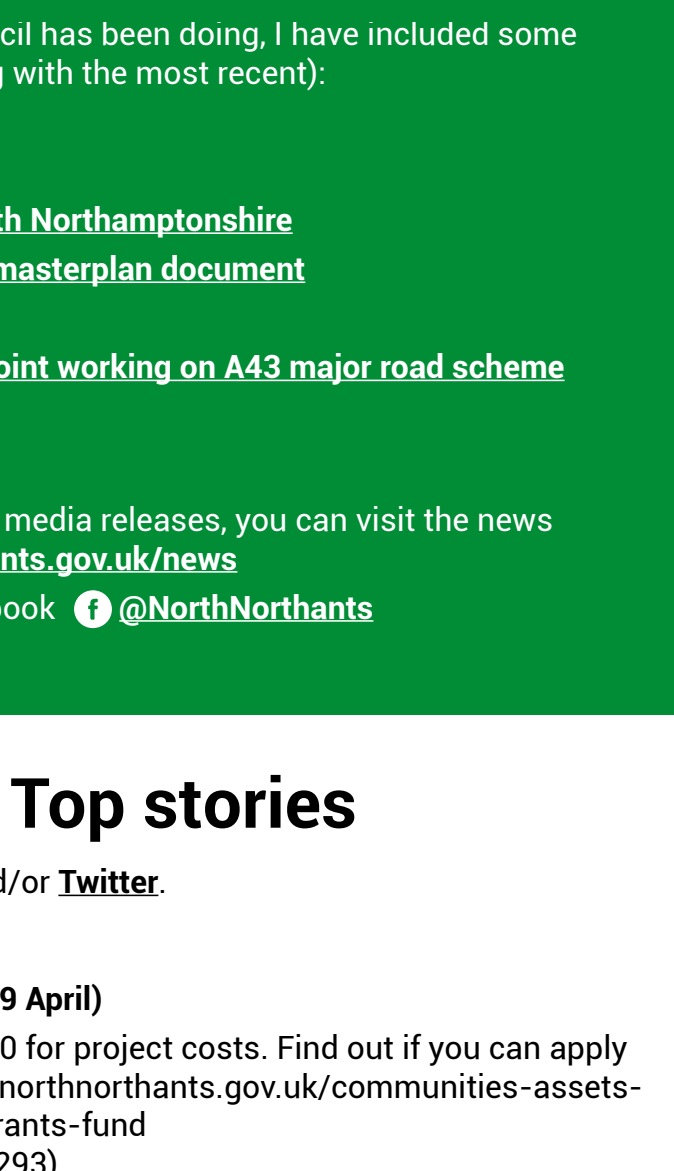
If you get an Emergency Alert on your phone, you'll hear a loud, siren-like sound. A message on your screen will tell you about the emergency and how best to respond.

You'll be able to check an alert is genuine via the GOV.UK website.

If you receive an alert, read the alert carefully and follow the instructions.

You can opt out of receiving emergency alerts.

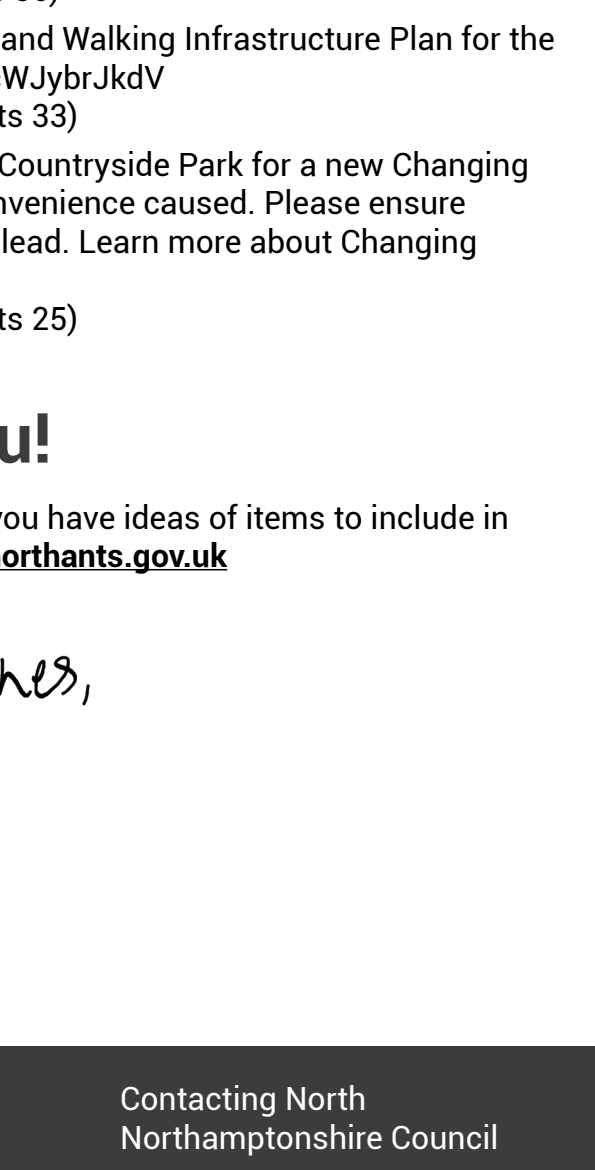

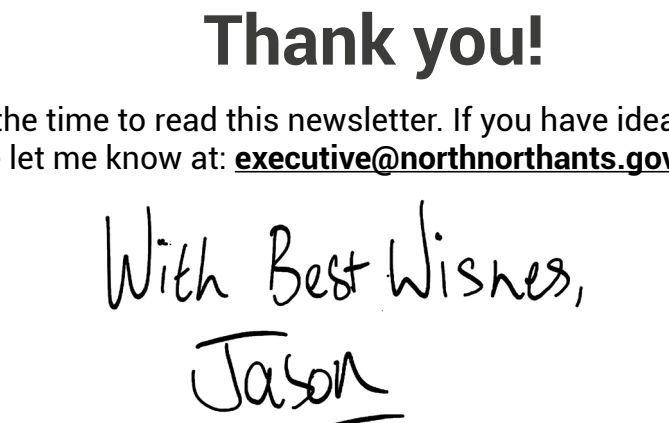
