20.56 PLANNING CONSULTATIONS

20/00813/FUL Single storey side and rear extension at 4 Higham Road

After consideration of the planning documents it was proposed and

RESOLVED

The Parish Council does not object the proposal providing the materials are sympathetic to the existing structure. The decision is made on the assumption that there are no objections from adjoining properties.

20/00837/FUL Two storey rear extension; first floor extension over existing single and 1.5 storey side element at 8 Hill House Gardens

After consideration of the planning documents it was proposed and

RESOLVED

The Parish Council has considered the planning documents available and has resolved to object to the application as the ridge line appears to be contrary to Supplementary Planning Policy.

In the event that the application does proceed the recommendations in the arboriculturalists report for the protection of the sycamore tree [T1] should be included as planning conditions.

20/00939/TPO T1 Sycamore - remove younger low growth that is overhanging number 14 Hill House Gardens, up to a height of 5.5mtrs. Reduce single large limb that extends over the patio and house of no 14 Reasons: To reduce the chance of the limb failing, to improve light and reduce falling debris at 12 Hill House Gardens

After consideration of the planning documents it was proposed and

RESOLVED

The Council is of the opinion that the proposal to lift the branches to 5.5m is excessive as the applicant has not provided evidence that the tree is in any way unhealthy or the presence of these branches is detrimental to the tree.

The Council will rely on the expert opinion on the East Northamptonshire Council tree officer in this matter.

The template document for use in staff appraisals as approved by the Staffing Committee had been circulated to all councillors prior to the meeting. It was noted that a protocol outlining the council's approach to appraisals and governing principles would be considered by the Staffing Committee and it is expected that this will be presented to the Council for approval at the September meeting.

20.60 NEW LEASE FOR STANWICK ROVERS FC

Further to Minute 20.45 (July 2020) correspondence from the solicitor together with a draft lease. Following a discussion it was proposed and

RESOLVED

The Solicitor should be advised that the Council has determined that this is a ground lease and that the Club should be required to insure any premises. Therefore the draft lease should be amended reflect this situation, requiring the Club to insure with premises with the council's interest in the land noted. The lease should require the Club to secure the council's permission and approval for any alterations within the area covered by the ground lease.

20.61 ANPR CAMERA ON WEST STREET

The Office of the Police, Fire & Crime Commissioner has consulted the Parish Council on the proposal to install an ANPR (automated number plate recognition) camera on West Street as part of a county wide project. It was proposed and

RESOLVED

That the Parish Council fully supports the proposal.
